Old Business:

Fair Improvements Project Cost Updates (if any)

- Show Arena Panel (Powder Coat) Project; Total cost of \$2,500 (Sanders Co. Fair). Following discussion it was approved (McGuigan motion) to allocate \$1,000 towards this project.
- Interior Sheep/Swine Barn Painting (power wash \$65-70), paint sprayer rental (\$55/each), paint (\$300 estimate). Total project estimate ~\$500. *Project approved*.
- ▶ <u>Digital Scales</u> (approximate cost ~\$1,800); discussed needs (platform improvement/location versus the current set-up. The current scales are certifiable, granted gates could be looked at. It was decided to *table the project* at this time.
- Animal Science learning kits. Horse club has a kit purchased. Discussed purchasing kits for sheep and swine education, especially considering the number of swine project members. They are developed and sold by Ohio State University and contain interactive sections on conformation, basic health, breeds, and meat "cuts". (Note-Price is \$429/kit)

Sheep/Swine Tagging: Friday, May 29th 6-7 pm Trout Creek Fire Hall; Saturday, May 30th 9-10 am, Hot Springs Scales.

Livestock Raffle: Weaner pig, quilt and quilt rack (Noxon Explorers) are donated. Clark Fork Custom Processing cost. Kill fee = \$60, cut/wrap is 50 cents per pound. Total processing for a market hog is \$175-200.

Old Business:

Fair Wrap-Up (critique)

Wednesday Check-In; everyone pitched in and helped. Need extra health cards as members need them upon arrival. There is apparently some confusion reading the barn patrol schedule, we'll look at page layout & having copies available for Camping Coordinator, Joe Brown to clarify with arriving campers.

Health Check-in; Thanks to Dr. Konitz for his continued assistance. 2009 will add Ferret rabies/distemper vaccination and are considering making strangles a requirement for horse projects. Strangles vaccine must be vet administered, so cost could be an issue. Having a spring vaccination location could reduce costs. Having an identified "Vet on Call" during the fair for 4-H/Open class livestock was discussed. We have coordinated with the Fair to share on call expenses (\$50 ea/day). This will be addressed for 2009.

Barn/Show Reports

Sheep; Sandy reported the show went well. As with swine, people traffic through the barn during the show is a problem.

Swine; showmanship & market show went very well. Safety: Matt reported that he & safety crew had difficulty keeping public and parents out of the barn during the shows and that safety. Concern is somebody may be injured when animals are being moved in/out of the barn. The same concern exists during the sheep show. Recommend separating members waiting to be interviewed from the judges. Consider raising the 210# market project minimum to 220 or 230. We will gather information over the next few months. Market Swine will be weighed once, after arrival at the fairgrounds.

Horse; Michele reported the show went well, she had a good crew assisting.

Beef; the show went very well, wash rack drains became plugged at one point, but functioned well otherwise. John Bras has a market steer available for 2009.

Rabbit/Poultry; address crowd control during the Friday rabbit show, traffic made hearing the judge's comments difficult. One concern is maintaining adequate feed records for poultry raised under "free range" conditions. At Wednesday check-in some feed sheets were left blank. Jim will request the open class rabbit/poultry entries be included with the materials he receives as Open Class Livestock Superintendent.

Round Robin; splitting the junior & senior shows seems to be working well. Respective showmanship winners need to notify their barn superintendent in a timely manner if they will (*not*) be participating.

Show (Public) Safety: has become a problem again during the swine & sheep shows. Barn Superintendents relayed a couple situations where young and/or older people could have been injured as animals are being moved in/out of the arena during shows. "Safety crew" leaders have voiced similar frustration. We'll pursue this further & continue to look for solutions.

Camping/Parking; Joe reported camping went well overall. All parents are reminded that youth shouldn't be left unattended. Some campers missed regular patrol schedule, but made up for it later. The format may need to be revised for ease of reading. Joe requested that when people sign-up, they indicate tent/RV and if RV, length. Gate at horse barn was left unlocked, needs to be locked to prevent in/out traffic. Padlock key left with camping coordinator.

Market Sale; 2009 will make copies of "quick reference" sheets in triplicate. The issue of members and buyers being contacted for Thank You ad space was discussed.

Livestock Committee Raffle (swine/welding display/quilt): \$1,724.51 was raised in support of livestock sale and committee improvement activities on the fairgrounds. 2009 cut/wrap fees if a market hog is the top prize.

Carcass Evaluation; Thanks to Gary Hewitt, Carrie Guenzler, Darreck McDonald, Matt Havens & Mike Frey of Clark Fork Custom Meats for assisting throughout the day.

New Business:

2009 Fairground Improvement Suggestions/Ideas; 1) concrete ramp for dumpster near beef barn, 2) paint the inside of the sheep & swine barns. 3) It is possible we will be developing additional pens if interest continues to grow in the swine project.
